

TENDER DOCUMENT

EXTERNAL AUDITORS APPOINTMENT FOR THE YEAR 2016- 2017 & 2017-18

Karachi Infrastructure Development Company Limited (KIDCL) is an unlisted Public Limited Company, wholly owned by the Government of Pakistan, working under the administrative control of Ministry of Communications, having its registered office in Karachi. The Company has been assigned to execute the PSDP Project "Green Line Bus Rapid Transit System" in Karachi.

2. This Tender Document is for the appointment of External Auditors for the audit of accounts of Karachi Infrastructure Development Company Limited (KIDCL) for the period FY 2016 – 17 and FY 2017 - 18 (two years), in terms of Rule 36 (a) of Public Procurement Rules, 2004 by hoisting the document on client's website as well as on PPRA's website as the estimated cost of services are under the limit of Rs. 2 Million.

3. KIDCL intends to invite application from "A" Category Audit Firms for appointment as External Auditors for the Financial Year 2016-2017 and 2017-2018. As per Scope of Work, Interested Audit Firms are requested to submit complete information as per following details:

1. Copy of registration of firm
2. List of existing clients in the Public and Private sectors
3. Number of partners along with qualification and experience
4. Number of qualified accountants employed
5. A copy of the Quality Control Review (QCR) rating of the firm by the ICAP
6. Details of International Affiliation (if any)
7. Audit Fee & out of pocket expense for the year to be charged in case of appointment as per scope of work
8. Presence of the Firm at different locations in Pakistan
9. Audit Firms are invited to participate in the tender along with relevant documents and complete firm profile.

4. This Tender Document is being issued by the Karachi Infrastructure Development Company Limited (KIDCL) upon payment of Rs. 1,000/- in the form of PO / DD in the name of "Karachi Infrastructure Development Company Limited, Ministry of Communications". 5. Sealed Quotations clearly marked as "Appointment of External Auditors for the Year 2016 – 2017 and 2017 - 2018" should reach this office latest by 17th January 2017, 11:00 a.m. and will be opened in presence of firms' authorized representatives, on the same day at 12:00 noon.

SCOPE OF WORK

7. Karachi Infrastructure Development Company Limited requires the services of "A" Category Audit Firms (under Circular No.5/2014 of SECP) in respect of the following services as per the provisions of the Companies Ordinance and relevant rules including Public Sector Companies (Corporate Governance) Rules, 2013:
8. For the year 2016 – 2017 and 2017- 2018, following services are envisaged:
- Annual Audit of KIDCL and issue Auditor's Opinion on it to Shareholders.
 - Review on Company's Compliance with the requirements of Code of Corporate Governance and issuance of Certificate of compliance with Corporate Governance Rules to Shareholders.
 - Review of Procurement as per PPRA Rules 2004.
 - Payments made to the appointed contractors, consultants, and other agencies in respect of PSDP Project, Green Line BRTS.
 - Any other audit / review required under the Companies Ordinance and Corporate Governance Rules/Code and issuance of certificate thereon (If any).
 - All firms should state lump sum fee for the year as mentioned above, in their proposal. Any other out of pocket expenses should also be mentioned separately.
 - Continuation of services for next FY i-e 2017 – 18 is contingent upon efficient services as External Auditor and with approval of AGM / Board of Directors.

Taxes and Duties

9. All prices must be quoted in Pak Rupees and should include all taxes applicable, such as SST, GST, Income Tax, etc. If not specifically mentioned in the quotation, it will be presumed that the prices include all the taxes. Any subsequent change in tax regime would be adjusted accordingly.

Confidentiality

10. The CA Firms, their partners and personnel shall maintain an appropriate standard of confidentiality and shall not disclose any proprietary or confidential information relating to the audit of the KIDCL.

Eligibility Criteria

11. KIDCL invites firms of Chartered Accountants for the external audit who will meet the following criteria:
- The firm should be registered with ICAP and have satisfactory QCR rating.
 - The name of the firm should be borne on the Panel A of auditors as maintained by of the State Bank of Pakistan.
 - The name of the firm should be borne on other elite panel of auditors in Pakistan preferably international as well.
 - Applicant firms should have at least 20 years' experience in undertaking such assignments.

- e) The firm should be a member firm of Global Top Ten Accounting Network.
- f) The firm should have reasonable experience of auditing NPO/NGO and Public Sector Entities functioning under the PSE (Corporate Governance) Rules 2013;
12. The competing firms shall attach relevant documents or equivalence certificate to validate their eligibility vis-à-vis a-f above.

Instructions for Bidders

13. Bidders must read the instructions carefully and comply accordingly. Bidders are required to submit proposal in a sealed envelope. The proposal document submitted must be properly indexed, paginated and structured. The bidders shall submit their firm's profile, clientele, and references along with the bid.

i. **Language**

The bids along with any accompanying literature shall be prepared in English language only.

iii. **Submission of Bids**

- a) Complete proposal should be submitted latest by 1100 hrs on last date mentioned in the advertisement at the address given above. Bids will be opened on the same day at 1200 hours.
- b) Any clarification can be obtained from the Manager Admin and / or Manager (Internal Audit) or their nominees on any working day before close of the bid submission date. Any queries may be sent via email or by courier well before submission time.
- b) This is single stage procurement procedure (PPRA Rules) under least-cost / least evaluated method under Rules 36 (a) of Public Procurement Rules, 2004;
- d) The erasing and/or alterations, if any, in the bid shall be authenticated by the authorized representative of the bidder by his/her full signature.
- e) Ambiguous and incorrect answers and/or incorrect filling of Bid Documents

- f) Bids through cable, telegraph, telex, fax, or e-mail shall not be considered.
- g) The bids shall not rely on any interpretation or correction given by any person except the written addenda and/or corrigenda to documents issued by the KIDCL.

iv. **Bid Bond (Earnest Money)**

- a) The bidders shall enclose a "Bid Bond" in the shape of pay order equivalent to 2% (two percent) of the total bid value. The Bid Bond shall be in favor of "Karachi Infrastructure Development Company Limited (KIDCL), Ministry of Communications". The bond so furnished shall remain valid for a period of 90 days beyond the period of validity of the bid or till it is revalidated / extended for a period mutually agreed upon by the bidder and Karachi Infrastructure Development Company Limited (KIDCL), Ministry of Communications.
- b) As soon as an award is made, the provisions in the following paragraphs c and d hereafter, shall operate.
- c) The bid bond in case of unsuccessful bidders will be returned as soon as possible, after rejection.
- d) In case the bidder after acceptance of bid fails / refuses to perform, the Bid Bond will be forfeited and encashed.

v. **Comments and suggestions against this Tender Document**

Bidders are requested to thoroughly read this document and give their comments if the required objectives could be achieved with this proposal. If any bidder elects to suggest changes to the proposal, complete information of the changes including all data relating to technical specifications in all categories shall be given along with the detailed methodology of carrying out the work. In such case the bidder must give proof of confirmation (POC) of being best in the light of the requirement stated in this document. This should be done at least one week before the submission of the bid.

vi. **Prices**

The prices quoted must be in Pakistani Rupees. The total cost shall include all the charges of the service extendable at mutually agreed location (Karachi), and inclusive of all taxes, levies, etc.

vii. **Validity of Bids**

Until the contract is executed finally, the successful bidder shall be bound by the terms and conditions of this Document.

- a. KIDCL may reject the bid if found incomplete / non-compliant;
- b. KIDCL reserves the right to cancel a bid prior to acceptance of bid; as per relevant provision of Public Procurement Rules, 2004;
- c. KIDCL reserves the right to cancel the offer of the bidder, whose bid may be evaluated to be the financially lowest, if it is revealed at later stage to KIDCL that the bidder does not have the capacity to execute the service or the amount quoted is so less that the delivery of the service is not feasible to carry out the Contract in accordance with the terms and conditions of this TENDER DOCUMENT or the bidder is blacklisted.

x. **Mode of Delivery and Address**

Sealed Bids shall be delivered by hand or courier so as to reach the address given above, by the last date and time indicated for submission. Bids received by fax or email shall not be read.
