Foreign firms shall meet the requirements of rules for participation in bidding process as stipulated in PEC Bye laws.
4. All technical bids must be accompanied by Original Bid Security in the amount of Rs.0.5 Million (5 lac) in the shape of Pay Order in favor of KIDCL.
